



# MAC Policy Steering Committee application form for 2024-25

This Missouri Association of Counties (MAC) policy steering committee application form should be completed and sent to the MAC office by **May 31, 2024**. Members may only serve on **ONE** policy steering committee, so please indicate your first, second and third choice for committee membership. If you are interested in serving as a chair or vice chair of a policy steering committee, please indicate that below. Policy steering committee members are expected to participate regularly in conference calls and meetings. Committee members need to stay informed of legislative and regulatory action relevant to your committee. Committee chairs and vice chairs will be responsible for establishing committee meetings and communications, and working closely with the MAC Board of Directors to craft policy resolutions to guide MAC’s legislative priorities. Committee leaders and members must cover their own travel expenses but meetings can be held virtually to help reduce costs and travel expenses to members. Meetings will also be held during some MAC events, such as the Annual Conference in November, Legislative Day during session and Summer Board Retreat in August.

**Committee terms last for one year beginning July 1 and ending June 30.** Appointments can be made during a committee term but will require another application for the next term.

- Each committee shall have no more than **10** voting members, unless approved by the president
- Committee members must be MAC members, but do **NOT** have to serve on the Board of Directors
- Stakeholders from outside agencies can serve on the committees but will be non-voting members
- Committee chairs will become members on the Board of Directors and serve on the Legislative Committee
